

## **NRSD Curriculum Standards for ELA**

### **Grade 6: Speaking and Listening (SL)**

#### **Comprehension and Collaboration**

**CC.6.SL.1 Engage effectively in a range of collaborative conversations (one-on-one and in groups) with diverse partners about grade 6 topics, texts, and issues, building on others' ideas and expressing their own clearly.**

**CC.6.SL.1a Come to discussions prepared, having read or studied required material; explicitly draw on that preparation by referring to evidence on the topic, text, or issue to probe and reflect on ideas under discussion.**

**CC.6.SL.1b With guidance and support from adults, work with peers to set rules for collegial discussion, clear goals and deadlines, and individual roles as needed.**

**CC.6.SL.1c Pose and respond to specific questions with elaboration and detail by making comments that contribute to the topic, text, or issue under discussion.**

**Grade 6: Language (L)**

**Conventions of Standard English**

**Conventions of Standard English**

**CC.6.L.2 Demonstrate command of the conventions of standard English capitalization, punctuation, and spelling when writing.**

**CC.6.L.2a Use punctuation (commas, parentheses, dashes) to set off nonrestrictive/parenthetical elements.**

**CC.6.L.2b Students will apply previously learned spelling rules and patterns, homophones, and knowledge of sight words to their written work. Students will edit their written work so that errors do not detract from the overall meaning of what they are trying to communicate.**

**Grade 6: Reading Literature (RL)**

**Key Ideas and Details**

**CC.6.RL.1** Cite textual evidence to support analysis of what the text says explicitly as well as inferences from the text.

**CC.6.RL.2** Determine a theme or central idea of a text and how it is conveyed through specific details; provide a summary of the text distinct from personal opinions or judgments.

**CC.6.RL.3** Describe how a particular story's or drama's plot unfolds in a series of episodes as well as how the characters respond or change as the plot moves toward a resolution.

**CC.6.RI.4** Determine the meaning of words and phrases as they are used in a text, including figurative, connotative, and technical meanings.

**Grade 6: Writing (W)**

**Types and Purposes**

**CC.6.W.1 Write arguments to support claims with clear reasons and relevant evidence.**

**CC.6.W.1a Introduce claim(s) and organize the reasons and evidence clearly.**

**CC.6.W.1b Support claim(s) with clear reasons and relevant evidence, using credible sources and demonstrating an understanding of the topic or text.**

**CC.6.W.1c Use words, phrases, and clauses to clarify the relationships among claims and reasons.**

**CC.6.W.1d Establish and maintain a formal style.**

**CC.6.W.1e Provide a concluding statement or section that follows from the argument presented.**

**Text Types and Purposes**

**CC.6.W.2 Write informative/explanatory texts to examine a topic and convey ideas, concepts, and information through the selection, organization, and analysis of relevant content.**

**CC.6.W.2a Introduce a topic; organize ideas, concepts, and information, using strategies such as definition, classification, comparison/contrast, and cause/effect; include formatting (e.g., headings), graphics (e.g., charts, tables), and multimedia when needed to aid comprehension.**

**CC.6.W.3a Engage and orient the reader by establishing a context and introducing a narrator and/or characters; organize an event sequence that unfolds naturally and logically.**

**CC.6.W.3b Use narrative techniques, such as dialogue, pacing, and description, to develop experiences, events, and/or characters.**

**CC.6.W.3c Use a variety of transition words, phrases, and clauses to convey sequence and signal shifts from one time frame or setting to another.**

**Grade 6: Writing (W) - continued**

**Production and Distribution of Writing:**
